## **ESSENTIAL FUNCTIONS:**

Under the supervision of the Director of Student Services and Building Principal, the position performs some or all of the following typical duties:

- Provide a full range of services to children ages 0-21, including screening and assessment.
- Design treatment programs, providing direct therapy and consulting with school staff, parents and outside agencies as appropriate.
- Assist in student placement and District program planning if appropriate.
- Plan, implement, and evaluate classroom instructional activities consistent with building and adopted District curriculum.
- Provide an enthusiastic and positive learning climate which promotes appropriate behavior and successful learning through a lens of cultural sensitivity and respect.
- Interact regularly and positively with students, colleagues, parents, and patrons of the school district.
- Assess the accomplishments of students on a regular basis, provide progress reports as required, and communicate with parents as deemed necessary.
- Participate in building and district-level meetings as needed.
- Maintain accurate, complete, and correct records as required by law, District policy, and administrative regulation including end of year reports and grant applications.
- Serve as a member of the multidisciplinary team to determine the child's eligibility for services, appropriate programming and ongoing progress and needs..
- Attend student/parent conferences if required.
- Other similar, related duties as required.

#### REPORTING RELATIONSHIPS

• Reports to and receives direction from Director of Student Services and Building Principal.

## **COGNITIVE DEMANDS**

• Requires organization and time management; requires adaptability and flexibility in working with different students, staff, parents, and community members; requires effective decision-making and problem-solving; requires dealing with difficult, upset, or angry individuals on occasion.
