### **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Vashon Island School District No. 402 from September 1, 2014 through August 31, 2015.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Associated Student Body events and fundraisers
- Financial condition
- Food Services cash receipting

- Open public meeting minutes
- Safeguarding of small and attractive assets
- Self insurance

Vashon Island School District No. 402 serves approximately 1,500 students from kindergarten through 12th grade. The District is located west of Seattle on Vashon Island. The District operates one high school, one middle school, one elementary school and offers two alternative learning program options.

An elected, five-member Board of Directors oversees the District. The Board appoints a Superintendent and the business manager approves budgets and handles other fiscal duties.
