## **AUDIT RESULTS**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

#### About the audit

This report contains the results of our independent accountability audit of Vashon Island School District No. 402 from September 1, 2015 through August 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended August 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- ASB fundraising activity at Vashon Island High School and McMurray Middle School
- Basic enrollment
- Financial condition

- General disbursements
- Open public meeting minutes
- Self-insurance of unemployment compensation

## INFORMATION ABOUT THE DISTRICT

Vashon Island School District No. 402 serves approximately 1,500 students from kindergarten through 12th grade. The District operates one high school, one middle school, one elementary school and offers two alternative learning program options.

An elected, five-member Board of Directors oversees the District operations. The Board appoints a Superintendent and the business manager approves budgets and handles other fiscal duties. The District operated on an approximately \$20 million General Fund budget for each fiscal year 2017 and 2016, respectively.
